1. Breeder guarantees that the above-described dog is a purebred Rottweiler, with British Kennel Club and is bred from Kennel Club registered parents. A true copy of its' pedigree shall be given to Buyer on date of purchase. Buyer shall duly register ownership of this dog with the British Kennel Club in the names of the Buyer(s) as listed above as owner(s) and with the dog bearing the name above which will include "Quebex" prefix.

2. Breeder guarantees that this dog is in good health at the time of purchase will supply Buyer with recommended diet Sheet. Buyer shall have the dog examined by a licensed veterinarian within 48 hours of purchase. Buyer may return the dog, for any reason, at Buyer's expense, to the Breeder within 72 hours of purchase with the registration duly signed and the dog unaltered, for a full refund of purchase price, less a £100 non-refundable fee. Buyer shall assume full responsibility for the health, temperament, and appearance of the above-described dog following said 72 hours. Buyer further agrees to maintain the dog at all times in good health with regular veterinary checkups.

3. The term "Show Prospect" does not mean that this dog is sold as breed able. If you decide that you wish to breed with the above said Registered animal, the Breeder will evaluate this dog/bitch at the age of 2 years to determine breed able status and will stipulate, in writing, whether this dog can be used for breeding purposes. To qualify for breed able status, dog must have a BVA hip score and BVA Elbow score (done between 12 and 24 months of age) preferably the same as/or lower than the BVA mean score but no higher than 20, be in

general good health and fitness and have been reared to maintain good temperament. Furthermore, the following conditions must be met prior to this dog ever being bred. Once these terms have been met and the breeder considers the dog and owners to be suitable the necessary Endorsements which are put on the Kennel Club Registration (progeny not to be registered) will be removed by the Breeder. The Breeder must agree to any mating in writing. All potential breeding partners must meet these same conditions unless otherwise agreed to, in writing, by Breeder. If this dog is a male, Breeder retains the right to use him at stud once to any one bitch owned or co-owned by her as long as said bitch also meets all breeding requirements. Buyer agrees that this dog shall not be used in any breeding to supply either directly or indirectly a pet shop, kennel or individual whose purpose is mass production, wholesaling, or retailing of purebred dogs.

4. It is further agreed to by the Buyer that proper safeguards will be taken to assure for the care and comfort of the dog sold herein. It is the understanding that this dog will have access to a fenced exercise area or a secure kennel area and the dog will have access to fresh water at all times. Buyer agrees not to use the dog for dog fighting, or promotes aggressive tendencies in said dog (unless this is supervised for Schutzhund or Personal Protection training in a controlled environment with an experienced handler/trainer for competition purposes or work). It is the mutual understanding of both Buyer and Breeder that this dog shall live out its' natural life as the companion of Buyer. If unusual or dire circumstances require that this dog can no longer remain in the possession of the Buyer, the Breeder is to be advised first .The Breeder must be given the opportunity of reclaiming the dog/bitch or re-homing him or her himself or herself, all this will be done at the Buyers expense. It is agreed to by Buyer that upon the death of this dog, at any age, prompt notice will be given to Breeder.

5. This Contract is entered into to ensure the well being and protection of this Rottweiler and the Rottweiler breed.

It shall not be subject to change or modification unless agreed to, in writing, by both parties.

ADDITIONAL AGREEMENTS MADE AT THE TIME OF CONTRACT SIGNING:

I have read and agree to abide by the terms of the six paragraphs contained in this contract, including any additional agreements as outlined above. I understand that this document contains the entire agreement of the parties and shall be binding to the parties signing, as well as their heirs, successors and legal representatives.
